RE: NOTICE OF CLAIMS PROCESS

On June 25, 2021, the Ontario Superior Court of Justice (Commercial List) in Toronto, Canada appointed **Grant Thornton Limited** as receiver (the "**Receiver**") of funds paid to the Ontario Securities Commission pursuant to settlement agreements and settlement orders between the Ontario Securities Commission tribunal and Ronald Mainse, David Rutledge, and 6845941 Canada Inc. carrying on business as Anesis Investments (collectively the "**Settling Respondents**").

The Ontario Superior Court Order authorized the Receiver to implement a claims process (the "**Claims Process**") for persons who invested money in Axxess Automation Investment and the Axxess Fund Investment (collectively, "**Axxess Investments**"); only investors who were introduced to Axxess Investments by the Settling Respondents are entitled to file a claim in the Claims Process. Note that certain parties related to the Settling Respondents are not eligible to file a claim – see the case website provided below for further detail.

If you were an investor who was introduced to the Axxess Investments by the Settling Respondents, and you did not receive a Notice of Claim from the Receiver, please go to the Receiver's website at www.GrantThornton.ca/Axxess for information on how you can make a claim under the Claims Process.
